

## USSVI Charleston Base Meeting Minutes

The attendance for the September 12, 2014 meeting was 101.

**Opening Ceremonies:** The meeting was called to order by Base Commander Ed Stank. A quorum was present and the meeting started at 1905. Following the Pledge of Allegiance the Invocation and Tolling of the Boats lost in September was given by Base Chaplain Nick Nichols. The USSVI Creed was read by Base Vice-Commander Jerry Stout. Ed welcomed the members and guests to the meeting.

**Secretary:** Vice-Commander Jerry Stout asked if there were any questions or changes about the August Meeting minutes as published in the base newsletter. Since there were none he called for a motion from the floor for the minutes to be approved. A motion was made by Mike Knaub and seconded and approved on a voice vote.

**Treasurer:** Base Treasurer Steve Morawiec read a report for the month of August.

**Vice Commander:** Vice-Commander Jerry Stout asked for nominations for the Distinguished Submariner and pointed out that the base election for next year will be for Secretary and Vice-Commander.

He also announced that the USS Clamagore Reunion will take place in Charleston, Oct. 16-20. The Veteran's Day Parade for Charleston will be on Sunday, November 3 at 2 pm. The Summerville Veteran's Day Ceremony will be Monday, November 11. Charleston Base is responsible for organizing the event this year which includes the speaker and wreath bearers.

He reminded that the base that the next meeting is 24 Oct at 1130 at Ryan's in Summerville. He thanked everyone who attended Pappy's services and said there were about 45 members there and that it really meant a lot to Pappy's family.

**Membership:** Membership Chairman Don Mook reported on the status of membership renewal.

**Newsletter:** Newsletter Editor Steve Morawiec reported that the September newsletter electronic and print versions have been sent out. Steve also pointed out that pictures from Pappy Henderson's Funeral and other base activities were on the Charleston Base Facebook page.
