

USS Lagarto (SS-371)

Lagarto, under Commander F.D. Latta, departed Subic Bay, Philippine Islands, on 12 April 1945, for her second patrol in the South China Sea. On 27 April, she was directed to the outer part of Siam Gulf.

Lagarto contacted Baya, already patrolling in Siam Gulf on 2 May 1945, and exchanged calls with her by SJ radar. Later that day Baya sent Lagarto a contact report on a convoy she had contacted consisting of one tanker, one auxiliary and two destroyers. Lagarto soon reported being in contact with the convoy, and began coming in for an attack with Baya. However, the enemy escorts were equipped with 10 cm radar, and detected Baya and drove her off with gun-fire, whereupon the two submarines decided to wait and plan a subsequent attack.

Early on the morning of 3 May 1945, Lagarto and Baya made a rendezvous at about 7°-55'N, 102°-18'E and discussed plans. Lagarto was to dive on the convoy's track to make a contact at 1400, while Baya was to be ten to fifteen miles further along the track. During the day, numerous contact reports were exchanged. At 0010 on 4 May after a prolonged but unsuccessful attack. Baya was finally driven off by the alert escorts, and no further contact of any kind was ever made with Lagarto.

Japanese information available now records an attack on a U.S. submarine made by the Minelayer Hatsutaka, believed to be one of the two radar-equipped escorts of the convoy attacked. The attack was made at 7°-55'N, 102°-00'E in about 30 fathoms of water, and in view of the information presented above, the attack here described must be presumed to be the one which sank Lagarto.

USS Lagarto (SS-371) Found in 2005

In 2005, a British diver reported discovering the wreckage of a submarine sitting upright in 225 feet of water off the coast of Thailand. While it appeared very likely that the Lagarto had been located, the U.S. Navy endeavored to make its own positive identification. A great deal of research and preparation, including a visit to the USS Torsk, a sister of Lagarto that is now a floating museum in the Inner Harbor of Baltimore, were undertaken before the salvage ship USS Salvor headed to the site. During six days of diving, 500 digital photographs and 10 hours of video of the wreckage were taken.

Divers had been briefed to look for a twin five-inch gun mount, a starboard anchor, and the propeller where the name of the submarine might be engraved. They found the gun mount and the anchor hanging to starboard. In addition, after scraping away decades of coral and marine growth, the letters "LA" were revealed on the propeller.



ARMED FORCES DAY May 18th

Many Americans celebrate Armed Forces Day annually on the third Saturday of May. It is a day to pay tribute to men and women who serve the United States' armed forces. Armed Forces Day is also part of Armed Forces Week, which begins on the second Saturday of May.



MEMORIAL DAY May 27th

Memorial Day, originally called Decoration Day, is a day of remembrance for those who have died in service of the United States of America. It's difficult to prove the origins of this day as over two dozen towns and cities lay claim to be the birthplace. In May 1966, President Lyndon Johnson stepped in and officially declared Waterloo N.Y. the birthplace of Memorial Day.

Regardless of the location of origins or the exact date, one thing is crystal clear – Memorial Day was borne out of the Civil War (which ended in 1865) and a desire to honor our dead. On the 5th of May in 1868, General John Logan who was the national commander of the Grand Army of the republic, officially proclaimed it in his General Order No. 11.

Part of the history of Memorial Day meaning will show that in the Order, the General proclaimed, "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land." Because the day wasn't the anniversary of any particular battle, the General called it, The date of Decoration Day.

On the first Decoration Day, 5,000 participants decorated the graves of 20,000 Union and Confederate soldiers buried at Arlington Cemetery while General James Garfield made a historic speech.



SUBMARINER MEDAL OF HONOR RECIPIENTS

The submarine community has eight Medal of Honor recipients. This is the fourth of eight in this series.

COMMANDER EUGENE BENNETT FLUCKEY


- RANK: COMMANDER (HIGHEST RANK: REAR ADMIRAL)
- CONFLICT/ERA: WORLD WAR II
- UNIT/COMMAND:U.S.S. BARB (SS220)
- MILITARY SERVICE BRANCH: U.S. NAVY
- MEDAL OF HONOR ACTION DATE: DECEMBER 19, 1944 FEBRUARY 15, 1945
- MEDAL OF HONOR ACTION PLACE: NAMKWAN HARBOR ALONG COAST OF CHINA, CHINA

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty as commanding officer of the U.S.S. Barb during her 11th war patrol along the east coast of China from 19 December 1944 to 15 February 1945. After sinking a large enemy ammunition ship and damaging additional tonnage during a running two-hour night battle on 8 January, Comdr. Fluckey, in an exceptional feat of brilliant deduction and bold tracking on 25 January, located a concentration of more than 30 enemy ships in the lower reaches of Nankuan Chiang (Mamkwan Harbor).

Fully aware that a safe retirement would necessitate an hour's run at full speed through the uncharted, mined, and rock-obstructed waters, he bravely ordered, "Battle station[--torpedoes!" In a daring penetration of the heavy enemy screen, and riding in five fathoms of water, he launched the Barb's last forward torpedoes at 3,000-yard range.

COMMANDER EUGENE BENNETT FLUCKEY

Quickly bringing the ship's stern tubes to bear, he turned loose four more torpedoes into the enemy, obtaining eight direct hits on six of the main targets to explode a large ammunition ship and cause inestimable damage by the resultant flying shells and other pyrotechnics. Clearing the treacherous area at high speed, he brought the Barb through to safety, and four days later sank a large Japanese freighter to complete a record of heroic combat achievement, reflecting the highest credit upon Comdr. Fluckey, his gallant officers and men, and the U.S. Naval Service.



Getting to know Our New Base Members

Bill Carman, MMCS(SS)/Lt (ret)

I was raised as an Army Brat which means we really never had a place that I would call a Home Town. Most of my young life was at Ft Bliss, Texas with a four year intermission at Ft Wainwright, Alaska, then returning to El Paso. I joined the Navy. Oct. 13,1970.

I went to Nuclear Power School, Bainbridge, Md. Didn't get a lot of free time while there, but survived and graduated in the top 10% of my class. From there I progressed to NPTU Ballston Spa, NY. I graduated from there in the top 10% in July 1972. I was stationed aboard USS Thomas Jefferson SSBN 618(G), New London, Ct., my CO was CDR "Smiling" Jack Darby, he later became ComSubPac. I made my first refit in Rota Spain that year and deployed on my first underway in November 1972. Even as a NUB I fell in love with Submarine duty. I qualified submarines August 23, 1973. While in the shipyard I got married and we moved to Pearl Harbor, deploying out of Guam. In 1977 my oldest daughter was born while I was underway, I met her a couple months later. In 1979 I was selected for Chief, I proudly went through my Chiefs initiation in Pearl, then received orders to be Command Career Counselor, Naval Nuclear Power School, Orlando.

While in Orlando we started the first class of females in the Nuclear pipeline. I was impressed. I was selected for and promoted to MMCS(SS). My second daughter was born, May 1980, Memorial Day, and I brought my first home. My detailer found me a fast attack as a Bull Nuke on the USS Flying Fish SSN 673 for two years for two years. I applied for the Limited Duty Officer Program while on board and was selected in 1984. I accepted the commission and was promoted while on board. The CO had my completed EOOW card in hand and sent me back to take the watch and immediately ran a drill set, what a thrill. From there life was less exciting but still fun.

I served for about 18 months with NRRO in Charleston. Then to the Frank Cable AS-40 as R-2 Div-O and then the Nuclear Repair officer. Frank Cable was sent to La Maddalena, Italy. I was assigned to Trident Refit Facility, Kings Bay as a Plank owner. Then transferred down the road to Oak Ridge, ARDM-1 as the Engineer Officer (Department Head) and after qualifying I was the Docking Officer, positions I filled until I left in 1993. My last duty station was at Naval Shipyard Charleston as the Nuclear Closure Coordinator. Retired as a LT on 1 March 1996 after 25 years, 4 months, 17 days of service.

Columbia Class Program Delays

The U.S. Navy is facing significant challenges with the construction of its latest submarines, including the Columbia-class ships and Block V variants of the Virginia class, due to supplier issues, delays, and spiraling costs. The first Columbia-class submarine's delivery may be postponed by a year to FY 2028, jeopardizing U.S. nuclear deterrence capabilities as these submarines are vital, carrying over half of the nation's operational nuclear arsenal. Delays are attributed to production issues, such as those at HII's Newport News Shipbuilding in Virginia and with Northrop Grumman's steam turbines. This setback occurs amid escalating tensions between Washington and Beijing, underscoring the urgency of maintaining a robust and timely defense capability.

Construction of the U.S. Navy's latest submarines is flagging amid delays, production issues, and exorbitant costs. Supplier issues are impacting Columbia -class ships and the Block V variants of the Virginia class.

The Navy recently released a rare public accounting that outlines these issues in detail. The service foresees a cumulative delay of more than a decade. As tensions continue to heat up between Washington and Beijing and a future kinetic conflict in the South China Sea becomes more likely, this report is concerning.

Regardless of what happens with the Columbia class, the Navy's Ohio-class submarines will be retired at a rate of one per year beginning in 2028. Only two Columbia-class ships – the USS District of Columbia (SSBN-826), and the USS Wisconsin (SSBN-827) – have been ordered so far. They will be followed by an additional 10 submarines...

WASHINGTON — On May 31, 2024, the Department of Veterans Affairs will launch a new program — the Veterans Affairs Servicing Purchase (VASP) program — to help more than 40,000 Veterans experiencing severe financial hardship avoid foreclosure and stay in their homes.

VASP is a new, last-resort tool in VA's comprehensive suite of home retention options for eligible Veterans, active-duty Service members, and surviving spouses with VA-guaranteed home loans who are experiencing severe financial hardship. Through VASP, VA will purchase defaulted VA loans from mortgage servicers, modify the loans, and then place them in the VA-owned portfolio as direct loans. This will empower VA to work directly with eligible Veterans to adjust their loans — and their monthly payments — so they can keep their homes. With VASP, these borrowers will have a fixed 2.5% interest rate, which will provide a consistent, affordable payment for the remainder of their loan.

Opening Ceremonies:

- The March 2024 Base Meeting was called to order by Base Commander Mike Ciesielko with a quorum of four officers and a total of 58 members. The meeting started at 1902 with the sound of the diving alarm.
- The Pledge of Allegiance was led by the Vice Commander Tom Lawson and recited by the members in attendance.
- The Invocation and the Tolling of the Boats lost during the month of March was given by Base Chaplain Nick Nichols.

- Base Commander Mike Ciesielko welcomed members and guests to the meeting.

Distinguished Submariner Award:

 Base Commander Mike Ciesielko, assisted by Vice Commander Tom Lawson, read the award citation and presented the Distinguished Submariner Award to Johnny Brown.

New Business:

 Base Commander Mike Ciesielko opened up the discussion of the proposed amendment to the Charleston Base By-Laws to reinstitute Associate Members. The complete text of the proposed amendment – as emailed to the entire Base Membership for consideration – was as follows:

PROPOSED BYLAW CHANGE FOR CHARLESTON BASE ARTICLE V – MEMBERSHIP Section 3. ASSOCIATE

- A. An Associate Member is a person who is not eligible for regular membership but is sponsored by a Regular Member and meets one of the following requirements:
 - 1. A family member of a Regular Member, including adoptive children of the Regular Member. (No limit.)
 - 2. A non-family member who has demonstrated a strong interest and support of the U.S. Submarine Service by their deeds or actions and is at least sixteen (16) years of age, subject to prior approval by the National Membership Chairman. (Limit one (1).)
 - 3. A non-family U.S. Military service member, Active or Veteran, who has demonstrated a strong interest and support of the U.S. Submarine Service by their deeds or actions, subject to prior approval by the National Membership Chairman. If separated from service, it must have been under honorable circumstances. (Limit one (1).)

- a) Some examples of interest and support are: Submarine Book author, Sub Tender service, Intel Rider, Museum submarine docent, Submarine Historian, or provides some other demonstrated service to advance the U.S. Submarine force.
- B. Each Associate Member must be continuously sponsored by a Regular Member in good standing.
- C. Associate Members are eligible for National and Base Annual Membership and must retain their membership in an established base to maintain their national USSVI membership. Associate Member annual dues will be the same as Regular Members.
- D. Associate Members are not eligible for Life Membership.
- E. Associate Members may vote on Base matters and may hold the elective Base offices of Secretary and/or Treasurer but not Base Commander or Vice Commander. Associate Members may serve on Base Committees as determined by the Base Commander.
- F. Associate Members are ineligible to vote in National/Regional elections and cannot hold National elected office.
- G. In the event an Associate Member's sponsor cannot or will not continue to sponsor the Associate Member (i.e., the sponsor is transferred or leaves the Organization), another Regular Member of the Base may assume sponsorship of the Associate Member. If no other Regular Member of the Base assumes the sponsorship, the Associate member will be dropped from membership.
- H. If the Associate Member is the widow, widower, child, or grandchild of a deceased Regular Member who was in good standing at the time of death, another Regular Member of the deceased member's Base may assume the sponsorship.

• There was much discussion and numerous members, including Rick Wise, Johnny Brown and others who offered constructive input, while some took to grandstanding and devolving the conversation into an argumentative event, claiming that the amendment would allow anyone [J.S.t.R] to join Charleston Base without considering the restrictions in paragraphs A.1, A.2 and A.3. At one point, our Treasurer Ricky Collins felt compelled to leave the meeting.

- John Lookabill presented a motion, which was seconded by Phil Nunnally, to strike Section 3 - Paragraph E from the proposal. The vote was taken by show of hands, resulting in the paragraph being removed from the proposal amendment. Subsequent lines F,G and H will be relabeled in the altered amendment as E, F and G.
- Prior to the vote being taken on the modified amendment, Nick Nichols explained the importance of the Associate Members in other Bases. Nick has witnessed and/or presided over the Eternal Patrol ceremonies of 168 shipmates during his tenure as Chaplain of Charleston Base.
- After a bit more discussion, with a call for the vote, one of our young members from NNPTC stepped up and walked around counting hands. The vote was cast with thirty-three (33) YEAs (in favor of the modified amendment) and twenty (20) NAYs (against the amendment – even after modification). After the meeting, Nick Nichols provided the full text of the changed amendment to be incorporated into the Charleston Base By-Laws. For clarity, Section 3 (as modified) is included, in its entirety, in these Minutes below:

ARTICLE V – MEMBERSHIP Section 3. ASSOCIATE

- A. An Associate Member is a person who is not eligible for regular membership but is sponsored by a Regular Member and meets one of the following requirements:
 - 1. A family member of a Regular Member, including adoptive children of the Regular Member. (No limit.)
 - 2. A non-family member who has demonstrated a strong interest and support of the U.S. Submarine Service by their deeds or actions and is at least sixteen (16) years of age, subject to prior approval by the National Membership Chairman. (Limit one (1).)
 - 3. A non-family U.S. Military service member, Active or Veteran, who has demonstrated a strong interest and support of the U.S. Submarine Service by their deeds or actions, subject to prior approval by the National Membership Chairman. If separated from service, it must have been under honorable circumstances. (Limit one (1).)
 - a) Some examples of interest and support are: Submarine Book author, Sub Tender service, Intel Rider, Museum submarine docent, Submarine Historian, or provides some other demonstrated service to advance the U.S. Submarine force.

- B. Each Associate Members must be continuously sponsored by a Regular Member in good standing.
- C. Associate Members are eligible for National and Base Annual Membership and must retain their membership in an established base to maintain their national USSVI membership. Associate Member annual dues will be the same as Regular Members.
- D. Associate Members are not eligible for Life Membership.
- E. Associate Members are ineligible to vote in National/Regional elections and cannot hold National elected office.
- F. In the event an Associate Member's sponsor cannot or will not continue to sponsor the Associate Member (i.e., the sponsor is transferred or leaves the Organization), another Regular Member of the base may assume sponsorship of the Associate Member. If no other Regular Member of the Base assumes the sponsorship, the Associate member will be dropped from membership.
- G.If the Associate Member is the widow, widower, child, or grandchild of a deceased Regular Member who was in good standing at the time of death, another Regular Member of the deceased member's Base may assume the sponsorship.

• With input of this change to the Charleston Base By-Laws, the current Section 3 & 4 must be renumbered to read as Section 4 & 5

Secretary - Gordon Long:

• The Minutes from the February Base meeting were emailed to all Base members. The February Meeting Minutes were approved as written.

Treasurer – Base Commander for Ricky Collins:

• The Treasurer's Report for February was published and promulgated on the website. There were no revisions. The report was approved as presented.

Chaplain – Nick Nichols:

- Something different this month instead of the highlighted boat of the month:
- 100 years ago this past Friday, March 8th, the first submariner received the Medal of Honor. President Calvin Coolidge presented Torpedoman's Mate 2nd Class Henry Breault the military's highest military decoration on March 8, 1924 due to actions in the Panama Canal the year before. According to his Medal of Honor citation, Breault was serving aboard the USS O-5 on Oct. 28, 1923, when a commercial vessel struck the sub, sinking it in less than a minute. He was in the torpedo room at the time of the collision but managed to make it to the hatch and escape. He soon realized a fellow submariner was left behind. Instead of jumping overboard to save his own life, he returned to the torpedo room to rescue a shipmate, Chief Electrician's Mate Lawrence Brown, he knew was trapped in the boat. Breault secured the watertight door to the torpedo room, giving the pair precious air and time. Breault locked himself and Brown inside. Safe there, they planned to wait for salvage divers. It took 31 hours, but the pair was rescued. Breault reenlisted several times and was promoted to the rank of Torpedoman's Mate 1st Class. He ultimately served in the Navy for 20 years before developing a heart condition, which claimed his life on Dec. 5, 1941. He was 41 years old.

There are several shipmates and family members who have given me information which they wish to be kept confidential at this time.

- Fran Wood, David Wood's wife, had bypass surgery in mid-February. She suffered a stroke on the table but is now moving her arm and leg on the left side. This is very good news.
- Wanda Yaeger, 87, Bill Yeager's wife of 64 ½ years, passed away on Feb. 15th after 5 days of hospice care. Her memorial service will be held at a later date.
